Sectors: education, industry, employment

- decision makers at national and regional level
- providers of IVET (for young people)
- providers of CVET (for employees and job seekers)
- employers

Labour market in CZ

Low unemployment rate – 2,9 % in
August 2017, EU 28 average 7,4 %
Advantages and disadvantages (GDP
growth 4,7 %, higher wages)
Limiting factor of economic growth
Qualification structure of job seekers two thirds of low qualified persons

National Register of Qualifications

- Almost 1,200 professional qualifications
- 26 sectors
- Every qualification described by qualification standard and evaluation standard
- Every aualification standard divided into several sections
- Authorized subjects (according to Law on evaluation and recognition of results of continuing education)

Employment services in CZ

Employment Office (managed by the MoLSA)

Central directorate, 14 regional branches, 230 contact departments 7 – 26 contact departments in a region

Mainly contact departments deal with job seekers

Pro-active employment policy

Specified by the Employment Law Several instruments:

- retraining
- investment incentives
- community services
- socially useful jobs
- several allowances/subsidies

- Step 1: job seeker selects a section of a qualification (promise of a job)
- Step 2: job seeker selects a training provider (confirmation, price)
- Step 3: job seeker submits his/her retraining application to Employment Office Guidance is provided by the EO

Debate on application at Employment Office (EO)

By a commission of EO

Decision on approval (yes/no)

There is no legal claim to approve the application

About half of application is approved

Administrative procedure between EO and training provider (contract)



- Examination by the authorised subject
- Authorised subject issues the certificate to job seeker
- About 10,000 cases of selected retraining in a year
- Costs: in average about 950 €

Are the learning outcomes specified? Yes

Is there clear assessment procedure? Yes

Are the acquired learning outcomes recognised? Yes
